What does the law say about 13, 14 or 15 years olds having sex? Most people wait until they are 16 or older before having sex. But sometimes young people have sex sooner. The law says: If the young person and their partner are heterosexual and are 13, 14 or 15 years old and they have sex they are both breaking the law

### **Young People, Sex and the Law - Healthy Respect**

Sex or any sexual activity between an adult and a young person aged under 16 is against the law in the UK and the adult will be held responsible for their actions. This applies to both men and women, whether they are of the same or the opposite sex of the young person and no matter what their cultural background is.

### **Sex, the law and you - Thinkuknow - home**

Specific laws protect children under 13, who cannot legally give their consent to any form of sexual

activity. There is a maximum sentence of life imprisonment for rape and assault by penetration. There is no defence of mistaken belief about the age of the child, as there is in cases involving 13–15 year olds.
